## What is Shipper's Interest Insurance?

Who's Covered	Shipper (you control your coverage)	Carrier
Coverage Level	Full vehicle value (up to stated limit) with minimal exclusions	Limited liability that often excludes essential coverage.
Claims Process	Handled directly with Tint	Through the carrier and/or their insurance company(s)
Claim Timeframe	As little as 7 days	Typically 30-90+ days
Deductible	\$100 flat per claim	Often N/A—but many gaps in coverage
Flexibility	Add per-vehicle as desired, no contracts	No control - depends on carrier's policy(s)
